## Weston Sailing Club Dinghy and Paddleboard Hire – Policy and Guidelines

The sailing club owns several dinghies and paddleboards (hereafter also called 'craft') which are used for training but are also available to hire by club members for either racing (dinghies only) or cruising use.

### 1. Club Hire Principles

- Club craft may only be hired when available, during times when the club room is open, and any of the Race Officer, Assistant Race Office, SSOS Lead, or a member of the General Purpose Committee (GPC) is available. At least 24hour booking in advance is essential and generally hire will not be allowed 'on the day'
- Club craft will **not** be available for hire if the prevailing, or forecast winds/gusts, are expected to exceed 20 knots (15 knots for paddleboards). **The Race Officer, or SSOS Lead, or GPC member decision on the wind is final**
- A session may last for the whole period of club sailing on that day, or until the hirer has finished using the club craft and advises this to the SSOS Lead or Race Officer. Paddleboard hire is for a full hour or multiples thereof. This may mean that a club craft can be hired again that day, subject to the 'Club Hire Principles' above, and the following guidelines
- The hirer is responsible for the craft and its equipment, together with the safety of the craft and crew, with due consideration to the weather conditions, sailing area, experience of the crew. The number of crew sailing a club dinghy is limited to the recognised maximum crew numbers for the class of dinghy (i.e. Pico and Laser - 1 crew, RS Feva - 2 crew, etc.).

### 2. Arranging the hire of the club craft

- All hire **MUST** be authorised by the Race Officer, or SSOS Lead, or GPC member ('**The Authoriser**').
- The Authoriser takes responsibility for the collection of this form, the hire fee and the safe return (and storage) of the club craft
- The Hirer **MUST** book in advance, complete a hire form, and pay the fees before use. All hirers will receive a confirmation email and show this to the Authoriser when they arrive at the club. Any special restrictions or limitations will be stated on this email
- Club craft may only be hired by adult Weston Sailing Club members or their guests. For dinghies, they must hold the RYA Level 2 certification or above and may be asked to produce their certificate. Other members who are undergoing training and wish to gain additional experience may be permitted to hire a club craft with agreement of the club sailing instructors on the day of the hire.
- Junior members holding the RYA Level 2 or WSC Helms competency certification may also hire a club dinghy when accompanied by an adult and may be asked to produce their certificate. In respect of Junior Members, the parent/carer is responsible for the completion of the hire documents and must remain at the Club for the duration of the hiring session.
- Junior members must not launch unless there is a safety boat on the water, or, this has been agreed with the Authoriser.
- Please note, there is **no provision for hiring out club craft to non-members**, other than guests of members, and subject to the club rules on guests
- The Authoriser, when agreeing the hire, may restrict the usage of the craft, or the sailing area, as deemed appropriate for the prevailing conditions, experience of the helm and/or crew, etc. Usually the area will be within the view of the Club House, Race Box, and safety boats. Only when agreed in advance may club craft be taken out of this area or land at any location other than the club foreshore and slipways.
- Weston Sailing Club reserves the right to refuse the use of any club craft for hire.

### 3. Using the club craft

- The Hirer must make sure they collect the correct equipment (e.g. sails, paddle, etc.) from the Training Shed or other locations as directed. The hirer should be able to rig the craft themselves at Level 2, however, please ask the authoriser if you have any doubts as to the correct rigging or safe operation of the club craft. (Mast floats must be used with Visions and the Feva)
- After your session, wash the dinghy or paddleboard with clean water and put everything away tidily where you found it. Do not leave easily removable equipment in, or on, the craft, except for the booms in the Feva and Visions.
- Dinghy covers must be put on and securely fastened, unless you are requested not to do so by the Authoriser.
- **If, in the opinion of the Authoriser, the hirer is deemed to be misusing the club craft or using it in a manner that is thought to endanger the club craft, its crew, or other people, the hirer will be instructed to immediately return the craft to the club (no refunds will be given).**
- All damage, loss, or other issue with the craft and its equipment occurring during the hire period **WILL** be deemed the responsibility of the hirer, if it was reasonably avoidable or results from misuse.
- All damage or issues **MUST** be reported to the Authoriser immediately with a written report. Clubs craft are insured, but the Hirer will be deemed liable to any excess suffered by the Club. Failure to timely and correctly report a potential insurance claim will make the hirer liable for the full cost of repairs.
- Buoyancy aids must always to be worn in accordance with WSC rules.
